## Who is eligible to vote?

You are eligible to vote in Minnesota if you are:

- At least 18 years or older;
- A citizen of the United States;
- A resident of Minnesota for 20 days immediately preceding the Election Day.

## How do I register to vote?

To register to vote, you can do any of the following:

Stop by our office Monday through Friday 8am - 5pm and complete a voter registration application.

# What if I have changed my name or address since I last registered?

Any previously registered voter who changes his or her name or address must reregister to vote. A change of name or address requires a new registration and a new signature from the applicant.

To register, please see the "How Do I Register To Vote?" section of these FAQs.

If you have moved since last registering to vote, it is important to update your voter registration information so you are voting for the candidates who will represent you.

# Why should I pre-register?

Pre-registration ensures convenience and quicker service when you arrive at the polls on Election Day.

You can register on Election Day, however you will need to bring proof of residency with you.

Please note there is a registration cut-off prior to every primary and every general election of 20 days before Primary Election and General Election Day. For registration after the cut-off, the best thing to do is register at the polls. ]Please check with our office for accurate dates.

# How do I register on Election Day?

You will complete a voter registration application at your polling place.

Be sure to bring one of the required following forms of identification showing your current address:

- Minnesota driver's license, learner's permit, identification card, or receipt for one, with your current address
- Tribal ID\*\*
- If the Minnesota license, Tribal ID or MN State ID has a former address, you may bring a recent utility bill\* to use with your license
- "Notice of Late Registration" postcard
- U.S. passport with utility bill\*
- U.S. military photo ID card with utility bill\*
- Prior registration listed on roster at former address in precinct
- Oath of a registered voter in precinct ("vouching", see below)
- If you are a student, you can use...
  - Student ID, registration, or fee statement with your current address
  - Post Secondary Student photo ID with utility bill\*

- Post Secondary Student ID if you are on a student housing list on file at the polling place
- For those who live in a residential facility. including nursing homes, battered women's shelters, homeless shelters and other licensed facilities, an employee who will vouch that you live there (if the facility has provided the county with a certified list of employees)
- **Vouching:** A voter may register and vote by having someone who is registered in the same precinct "vouch" for their residence. The voucher may be preregistered in the precinct or have registered on Election Day (but not by being vouched for). The registered voter signs an oath attesting (or vouching) to the new registrant's residence in the precinct. Vouchers within the polling place on Election Day can vouch for up to 15 voters, as long as they personally know the voters live in the precinct.

\*Note: The utility bill must have your name, current address, and be due within 30 days of the election. Utility bills may be for electric, gas, water, solid waste, sewer, telephone, cell phone or cable TV

## What if I am not registered but still want to cast an absentee ballot?

If you are not a registered voter, you can still register and vote by absentee ballot. A voter registration application will be included with your absentee ballot materials. The completed application is returned with your voted ballot. The voter registration application cannot be returned separately.

# Availability of Absentee Ballot Applications

Absentee ballots are available 46 days prior to the state primary and the state general election.

An eligible voter may vote by absentee ballot in person at the local absentee office in Rochester during the following times for the primary and general elections.

- During normal office hours (8:00 a.m. 5:00 p.m. Monday -Friday, excluding holidays) beginning 46 days before the election;
- On the Saturday before the election from 10:00 a.m. to 3:00 p.m.; or
- On the Monday before the election until 5:00 p.m.

- When returning your completed voted ballot *in person*, to the county or municipal office, the ballot must be received by 5 p.m. on the day before the election.
- When returning your completed voted ballot *by mail*, the ballot must be received (not postmarked) at the polling place on Election Day.
