**I. COMPOST/BRUSH SITE POLICY**

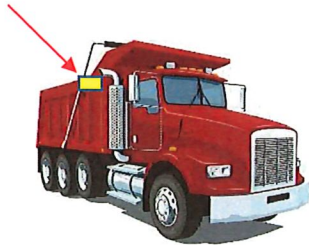
The purpose of the Compost/Brush site policy is to establish and maintain uniform definitions and procedures concerning compost and brush site operations for the City of Stewartville. The City will provide such control in a safe and cost-effective manner, keeping in mind personnel, and environmental concerns.

**A. Registration**

There is no fee to register at the City of Stewartville. **All assisted/power dump trailers and trucks MUST be registered prior to dumping.** This can be done at City Hall or emailing [TREE@stewartvillemn.com](mailto:TREE@stewartvillemn.com). The following information needs to be provided:

- Name
- Billing Address
- Phone Number
- Make and Model of vehicle
- License Plate
- Capacity/Dimensions of loading area

Once registration is completed, a sticker will be placed on the truck/trailer in the top front passenger side of the box.



**B. DUMPING**

The City of Stewartville **MUST** be notified by the end of the day that the material is dumped. Notification can be done by emailing [TREE@stewartvillemn.com](mailto:TREE@stewartvillemn.com) or calling City Hall, 507-533-4547, during normal business hours. A local service address will need to be provided with the quantity of debris. The compost/brush site is for Stewartville Residents material only.

**C. FEES**

Fees will be maintained and updated per the fee schedule. The per trailer/truck fees will be charged based on an Honor System.

- \$6 per yard, billed monthly
- \$100 Penalty for Failure to report same day dumping + Material Charge
- \$200 Penalty for dumping before registration or for dumping from outside city limits.

### **Fees:**

\$6/yard – Billed Monthly

\$100 Penalty for Failure to Report Same Day Dumping + Material Charge

\$200 Penalty for Dumping Before Registration or from outside City limits.
