**A. Solar Panel Project** – City Administrator Schimmel has been working with Peoples Energy Cooperative Power as they were proposing to install a solar panel garden within the city limits. City Attorney Guzinski has given his comments in regards to a draft lease that was presented. The site chosen is the area around the North water tower. The City has determined how much land would be needed for future improvements to the water tower and a possible well site. The Finance Committee is requesting direction from the Council on whether they would be interested in a project within the City limits. The Finance Committee is also recommending that the property be purchased by People's Energy Cooperative vs leasing it.

Council discussed the project noting that they would like to continue with the negotiations with the sale of the property vs leasing. Schimmel stated that he suggested that this site could serve as a potential maintenance station which would be a benefit to our community. He also noted that if future development occurred the community gardens may have to be relocated.

Motion by Anderson, second by Timm to continue with the proposed sale of the property to People's Energy Cooperative Power. Unanimously approved.
