A. 2017 CIP - City Engineer Obernolte presented the plans and specifications for the proposed 2017 CIP. Obernolte noted that Public Works Director Stevens has reviewed the plans and the project includes sidewalks on the north side of 6th Street NE, curb/gutter, new road, utility connections, storm water mains, subdrains and new water mains. Sewer mains will not be replaced. The new estimated cost of the project is \$1.35 million, down from the feasibility study cost of \$1.6 million. Bid opening is scheduled for March 28th at 10:00 a.m. with construction starting the first part of May and ending by Labor Day 2017.

Motion by Uptagrafft, second by Beyer to approve Resolution 2017-5, A Resolution Approving Plans and Specifications and Ordering Advertisement for Bids for 2017 Street & Utilities Improvements (6th Street NE and Fairway Court North). Unanimously approved.

B. Annexation – Midwest Baptist Church- It was brought to City Clerk Roeder's attention from the Board of Administrative Hearings that the joint Orderly Annexation Agreement between the City and High Forest Township needed to be renewed. The Township Board is expected to sign the agreement at their next meeting on March 7th which will extend the contract for five years. Due to this oversight, we need another motion to approve the annexation of Midwest Baptist Church.

Motion by Beyer, second by Anderson to approve Resolution 2017-6, A Resolution Extending the Joint Resolution for Orderly Annexation Between the City of Stewartville and High Forest Township. Unanimously approved.

Motion by Anderson, second by Uptagrafft to approve Resolution 2017-7, A Resolution Between the City of Stewartville and High Forest Township Extending the Corporate Limits of the City of

Stewartville, subject to the agriculture easement being signed between WB Properties, LLP and Leitzen. Unanimously approved.

C. Strikers Bar – A request had been received by Strikers Bar to utilize MN State Statue 340A.404 Sub.4 to sell intoxicating liquor at the Civic Center for a wedding on April 21, 2017.
